Locally, we are closing out our 2021 competition season. We have one Solo event, the Johnny Appleseed Road Rally, and our last event at Nelson Ledges Road Course that combines a full day of SCCA Track Sprints and a Time Attack competition on Sunday. Many of our Competition Team members will also be supporting the Mahoning Valley Region at their Golden Harvest Divisional at Nelson Ledges Road Course.

Notes from the Director's Chair Area 4 Director Update for September, 2021

After months of “meeting” my fellow BoD and CRB members via Zoom conference video connections, it was nice to actually meet them in Kansas City, MO at the end of July. The CRB was first on 7/30. This was an all day meeting was designed to be more strategic and focus on the long-term goals of the CRB. Nominations

TIME TRIAL AND TRACK ATTACK AT NELSON LEDGES

NEOHIO is excited to announce an additional **Time Trial** with a focus on an all-Day **Track Sprint**. The date will be October 16-17. We have decided to do this to help both Nelson Ledges with an open date and give an opportunity to introduce competitors that don't normally run on a closed circuit a safe & easy opportunity to get on track. Saturday will be a full day of Track Sprints. These are timed runs on Nelson Ledges Road Course with single car runs starting from a point on the track and finishing about 2/3rds away around the track. Each competitor will receive three runs on each of three track segments. The best run from each segment will be counted towards the day's championship. We are very excited to be able to offer this opportunity to our members and other motorsport enthusiasts in the area and easy way to get on Nelson Ledges. Sunday will be a standard **Track Attack** day. We have had a lot of competitors interested in another Track Attack single day event. The hope is some of the Saturday participants will stay for the weekend to try their hand at a Track Attack Day. A separate trophy award will be given for this event as well. For competitors that compete in both the Track Attack and Track Sprint in the same car will be eligible for a NEOHIO Time Trial Championship award. 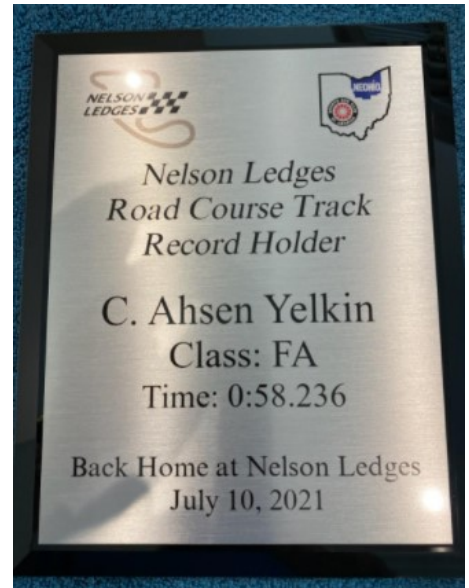

The award is selected annually by the previous three recipients, who in this case are Bryan Hayes, Tim White, and "The Eh Team" consisting of a group of competitors from eastern Canada.

It has been decided no Johnson Spirit of the Sport Award will be handed out for 2020, since that's a year most of us would rather forget. But the **2021 Johnson Spirit of the Sport Award** has been bestowed upon Team "For the Glory!!!" highlighting members Jeff Blumenthal, of the Neohio Region, and Kansas City Region members Dan Wheeler and Brad Smith. Almost as loud as the cars they drive, the cheers of "FOR THE GLORY!" can be heard far and wide at events with more than one class competitor. Along with having fun as the "black sheep" of the community, these competitors are self-sacrificing and can often be found helping their fellow competitors — whether in paddock or in grid in the heat of the moment.

Help Save the Monza at Adkins Raceway and Speed Center

Adkins's Raceway, a historic 6-turn go-kart track in Port Washington, is one of the last tracks in the country to maintain one of its original design features, the Monza, a turn with almost 30 degrees of banking! Adkins Raceway has been a family-run and operated track since 1982, spanning three generations. The track was officially reopened in 2015 by Kyle Adkins. Operations of the facility have now been taken over by Brandon Adkins, Kyle's son.

The property that the facility is located on is subdivided over multiple plots and was still owned by Brandon's Grandparents. Due to their failing health, portions of the property were required to be liquidated, and unfortunately for Brandon, the Monza turn partially sits on one of those plots. The Monza plot of land was recently sold at a liquidation auction and the gavel price was significantly higher than expected.

Help is needed to pay the bill for the Monza plot. Once the bill is paid, improvements can continue to be made at the facility, making it a great destination for racers of all types and all ages. The motorsports community is like family so let's help however we can to save the Monza!
