Notes from the Director's Chair Area 4 Director Update for February 2023

I apologize for the tardiness of this edition but I just returned from attending the Rolex 24 at Daytona and it was quite a week down there. A few adult beverages were consumed and I got a bit of a sunburn.

As you can see from the number of items below, January was a very busy month for Zoom calls on my calendar. As I mentioned last month, there's no such thing as an off season.....there is just the preparation for the next season.

Video Conference Meetings:

Club Racing Board (CRB) (1/3): We finalized plans for a second face to face meeting in 2023 which would be held in March (3/24, 3/25). The group reviewed changes in the data acquisition program. We also discussed ways to streamline the flow of information to and from the CRB and the BoD. The results of CRB rules changes can be seen [here](#).

Electrified Vehicle Advisory Committee (EVAC) (1/5): We added an additional meeting to consider the letters that had been sent to the EVAC through the CRB letter portal. There were several letters the EVAC had received about the SCREV and our Club Racing rules packages that needed extended conversation. The good news is that the members are asking serious questions of us and this proves they are engaged on the topic.

EVAC (1/11, 1/16): Due to some technical difficulties, our meeting was cut short on 1/11 so we were forced to add another meeting on 1/16 to continue the discussion. We chatted about the EVAC update session for the convention. We also got an update about safety training that would be required for the members who would interact with EVs at competition events.

Board of Directors (BoD) (1/17): This was an additional meeting convened to deliberate on one topic. We discussed how to alleviate the turmoil in the Rally Cross program and the best way to right the ship.

Great Lakes Division (GLDiv) (1/18): Several of us met to discuss the planning and schedule for the GLDiv Spring Training Meeting in Fort Wayne next month. Val McCammon updated us on what she had done so far and we chatted about how to enhance the experience for the members.

SCCA Convention (GLDiv Meet & Greet Session) (1/21): Several of us hosted a convention session for the GLDiv members. The idea was to give out information about the division officials and allow them to dispense aspects of each of the competition programs in the division. I started by showing slides of the officers and officials for the division. I was followed by Lauri Burkons as she chatted about the Club Racing program. Ray Jason, Velma and Raleigh Boreen reviewed the details of the upcoming Solo season. Vinnie Taibi passed on specifics about the Time Trails program. SCCA Convention (EVAC Session) (1/23): I hosted a session where we updated everyone on what the EVAC has been up to as well as where we are headed. 154 people tuned in for this one and it can be seen by following this [link](#).

BoD (1/30): As this was our first “normal” meeting of the year, we discussed items on a wide variety of topics:

The reorganization of the RallyCross Board (RXB)

Addition of a member to the SCCA Foundation Board

The revised Enduro rules package

The Dallas, TX meeting of the Solo Events Board (SEB)

We approved the members of the Time Trails Board (TTB)

We also looked for ways to enhance communication between the Club Racing Board (CRB) and the steward corps.

SCCA Events:

Rolex 24 Hour Race: While not strictly speaking an SCCA event, part of my rationale for going to this event was to see how the SCCA supports this race. I saw many SCCA members there and conducted some business during the race too. Like a lot of pro races, the SCCA supplies most of the corner workers. With a “4 hours on, 8 hours off” regimen, there needs to be scores of workers for this event and the vast majority are SCCA members. I roamed the grounds and spoke with the staff at several corners and found out they were from all corners of the country and even a few from overseas.

OHIO WINTER RALLY

After a pandemic-imposed hiatus, the Ohio Winter Rally returned as the second event in the 2023 SCCA Great Lakes Division Rally Championship (GLD) series. The rally started at DiBella's Subs in Solon, and finished at Unc's Patio Lounge in Auburn Township. In between, the approximately 165 mile course traversed portions of northeast Ohio's Lake Erie "snowbelt", and competitors visited many familiar haunts. The GPS based Richta automated timing and scoring system kept staffing needs to an absolute minimum.

This was certainly one of the driest OWR's ever. Wind patterns and temperatures have brought only a small fraction of the usual "lake effect" snow to northeast Ohio this winter.

Special thanks to the following individuals who worked behind the scenes making sure the rally was successful:

Jeff Arendas and Dave Killian performed the course precheck (probably the most thankless, yet most important organizational tasks). Dawn Smith handled on-site registration.

Amateur radio operators Pat Karl, N8ONI, David Andrzejewski, AD8G, and their colleagues drew up an Incident Action Plan" (IAP), and set up an amateur radio communications net across the entire course. "Hams" also helped with course opening and sweep duties. It's a luxury for a rallymaster to have live progress reports from on-the-ground observers. Informal activations such as this serve as excellent training grounds for amateur radio deployments during real emergencies. OWR has enjoyed support from the local amateur radio community for many years, thanks in part to the efforts of former Rallymaster Tom Kimball, KA8BZB, who passed away in early 2022.

Richta guru Jim Crittenden graciously volunteered to assist with remote scoring.

Bill Stewart volunteered to do a last-minute course drive-through on Friday, and returned to help with course sweep duties on Saturday evening.

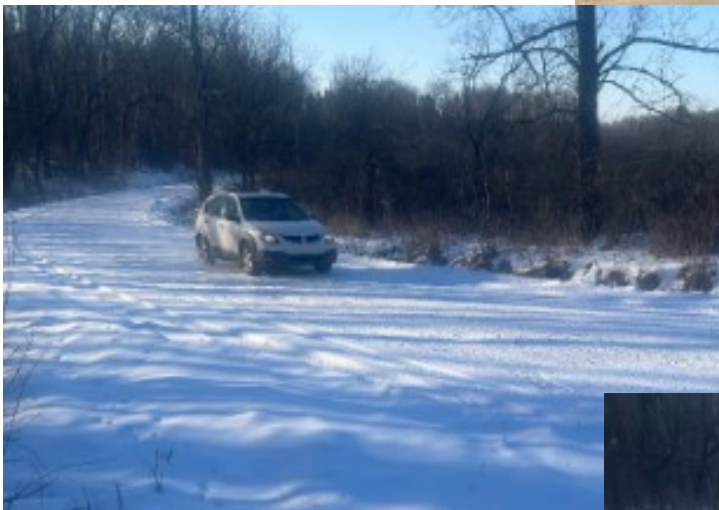
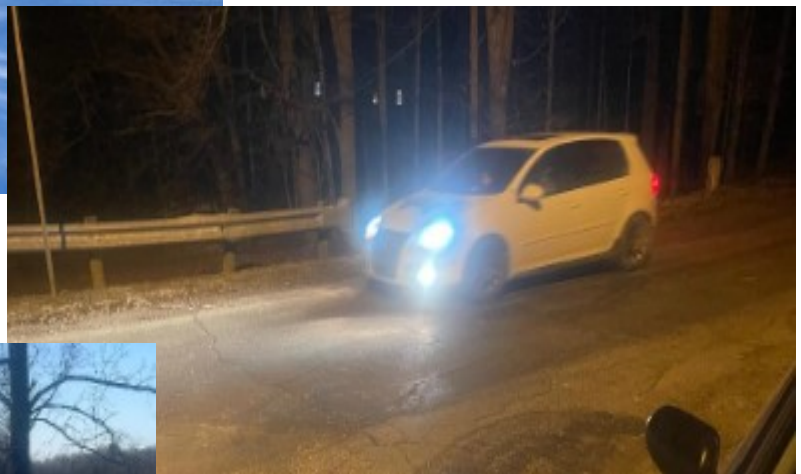
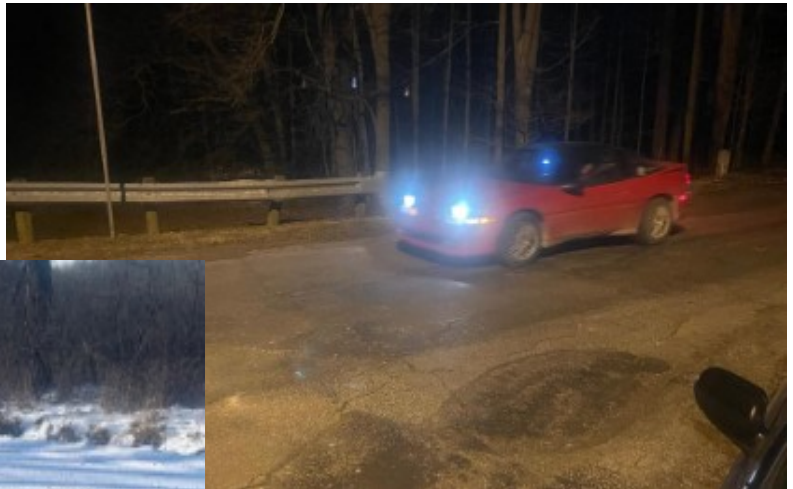
